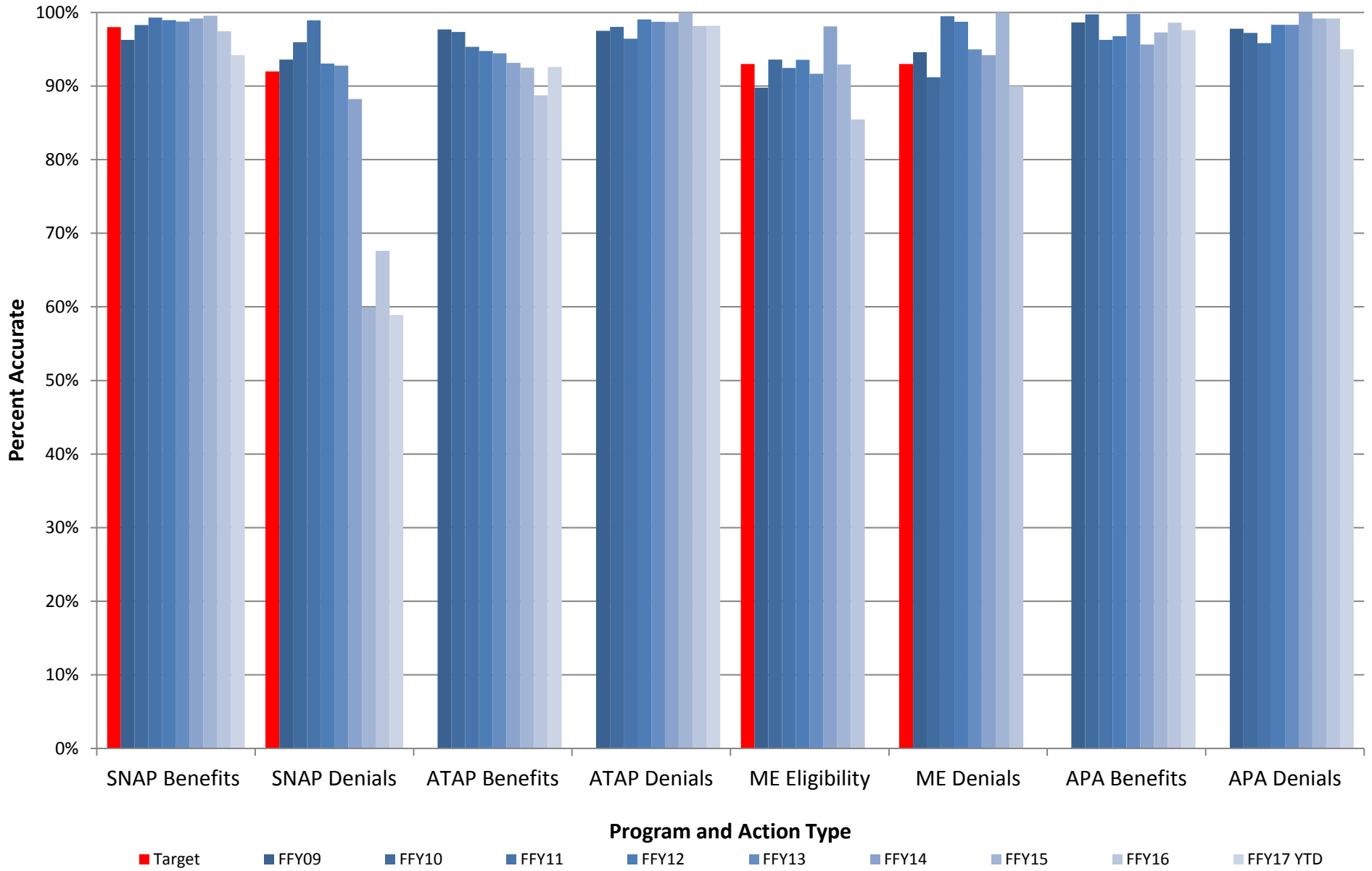

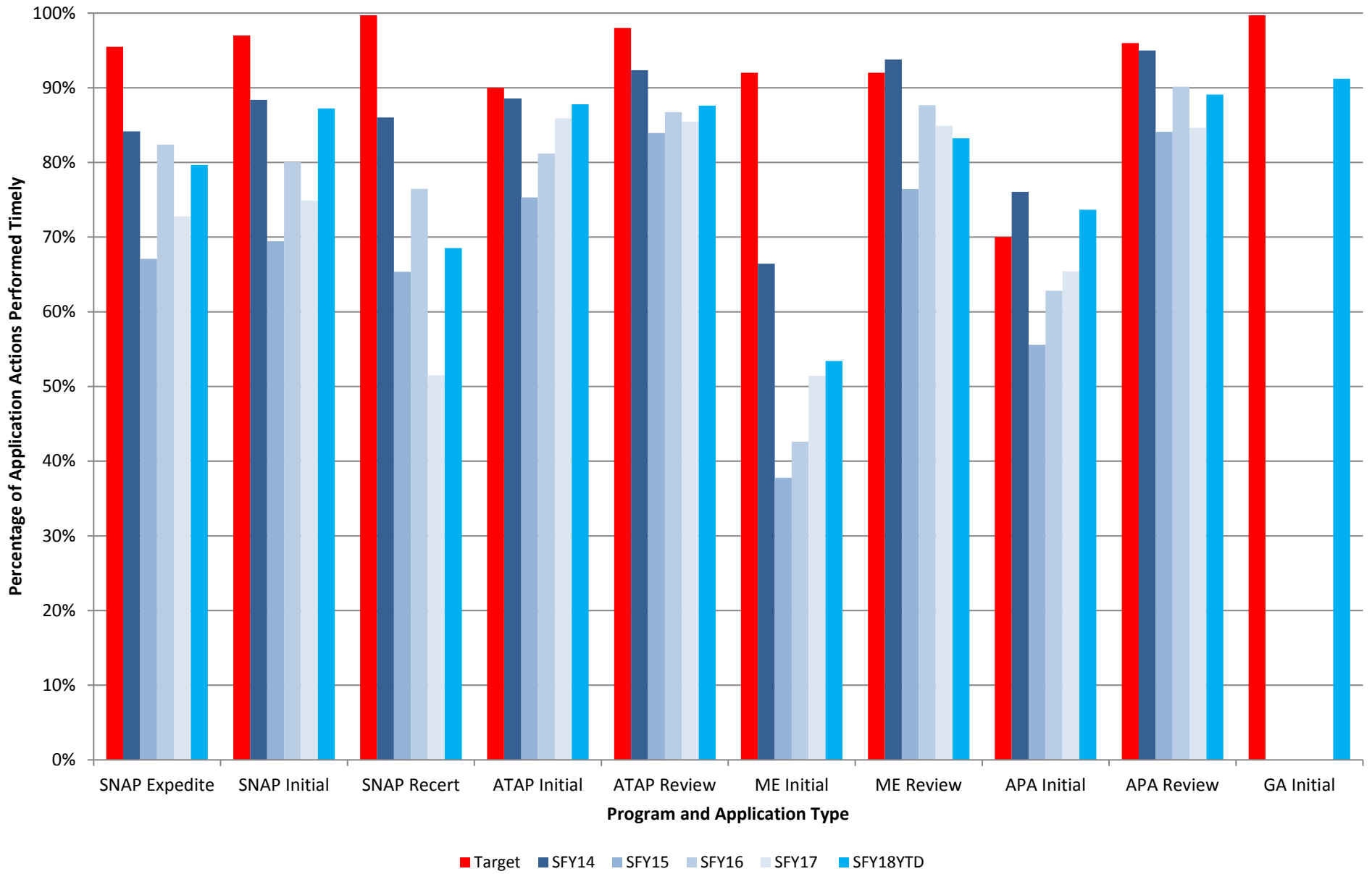

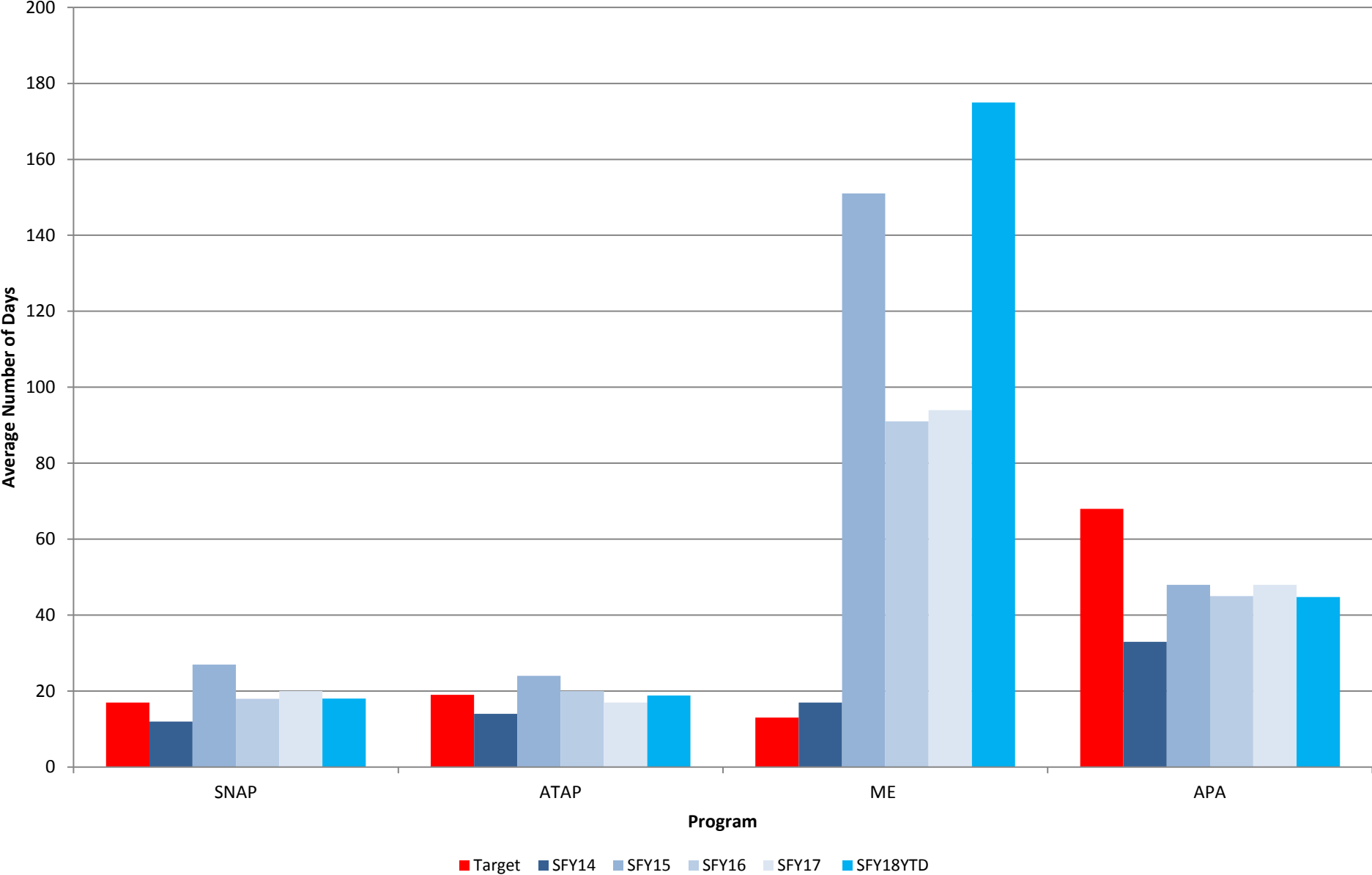
### Accuracy Performance



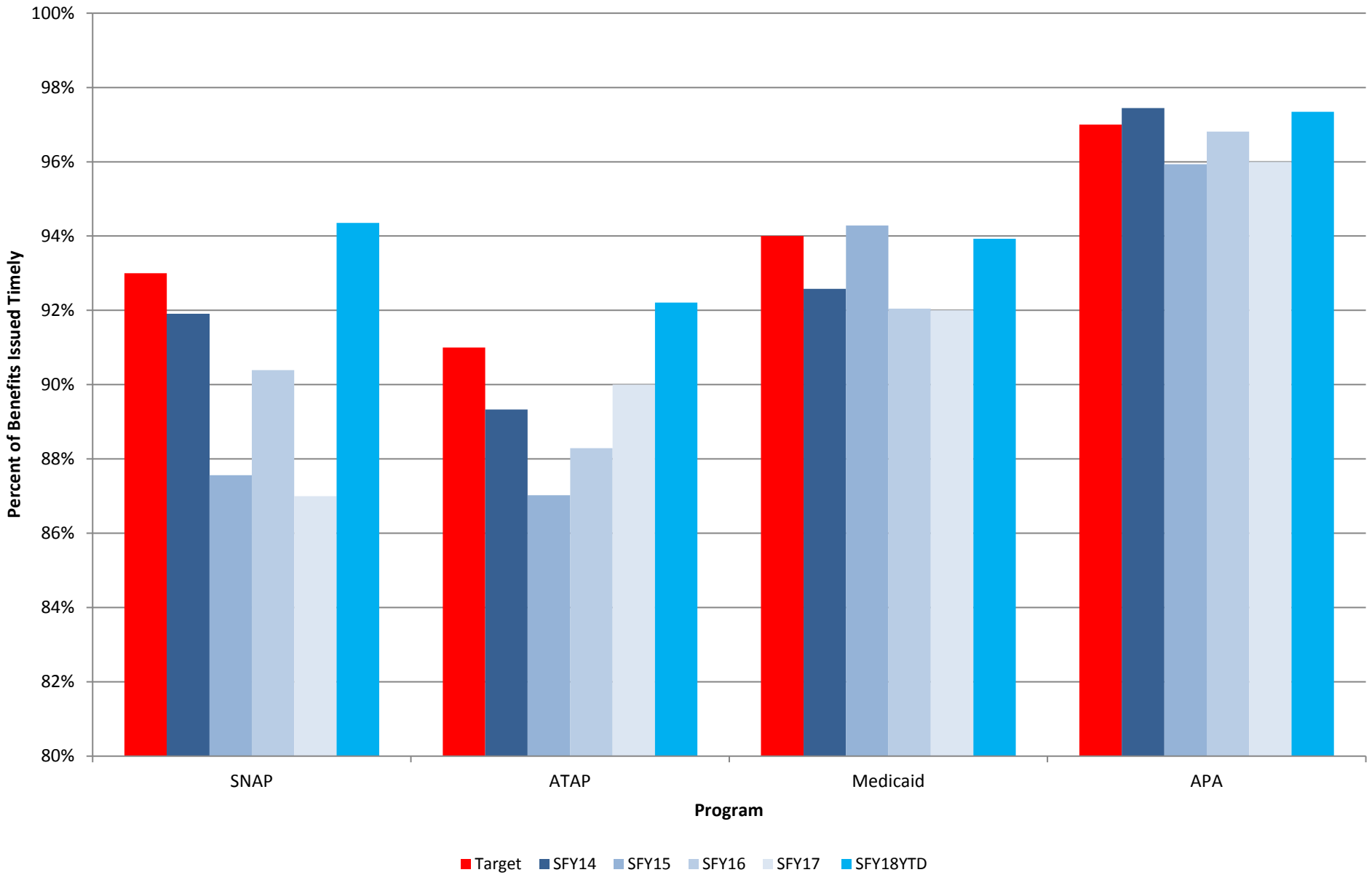
# Timely Application Actions Performance
